If your child is dropped off 15 minutes or more before 9am OR if your child is picked up 15 minutes or more after noon or 3pm, there will be a \$7 per hour or part of an hour charge. Please sign the clipboard located at the exit of Buildings ONE and TWO with your child's name and the date/time. Your balance will be calculated for you and is due with your next monthly tuition payment. Our hours of operation are 7am to 6pm. We charge \$1 per minute AFTER 6pm. There are no exceptions.

Tuition fees for the 2019-2020 School Year are effective August 2019. August Tuition is due Thursday, August 1, 2019 and on the first thereafter of each month. A \$10 late fee will be charged to accounts paid after August 05, 2019 and after the fifth of each month thereafter. Payments may be made in the School Office during office hours (8:30am to 3pm) OR you may place your check/money order in the black tuition drop box in Ms Sam's classroom, OR our mailing address is: MSDC, PO Box 272 Douglasville, GA 30133.

Tuition is assessed on an annual basis, with 10 monthly payments and is NOT subject to adjustment for illness, absence, or withdrawal of the child. In the event that you need to withdraw your child from our school, we ask that you provide us with a written and signed notice of withdrawal at least FOUR weeks prior to the withdrawal date. If an account becomes more than one month delinquent, parents will be asked to take their child out of School. School records will be released after tuition is paid in full. If we experience a problem collecting the fees and tuition due, the Parent/Guardian will be responsible for any attorney's fees, court costs, or any other costs related to collecting money owed to the School.

We are required by law to have the immunization Form 3231 for your child on file at the end of the first week of school.
